The details are in the notice of meeting which has been already sent to the shareholder. The Board of Directors' Meeting also passed a resolution to authorize the Board of Executive Directors of the Company or Chief Executive Officer as an authorized person, under laws' restriction, to amend or change the date, time, place, including the meeting agenda for the Annual General Meeting of Shareholders for the year 2021 as deemed appropriate.
